Terms and Conditions

1. Introduction:

- This document outlines the terms and conditions governing the **Keepit Pipeline Payday** program, designed to incentivize partner representatives to achieve deal registration targets within a designated period.

2. Eligibility:

- **Participants:**
All Sales and Technical Sales representatives from selected partners.

3. Program Details:

- **Targets:**

To earn awards, a sales or technical representative must register a qualified deal in the partner portal during the program period, which is from April 1, 2026, to September 30, 2026.

All actions, including Deal Registrations, must include a NET NEW customer to Keepit for qualification.

- **Minimum Qualifiers**
 - Partner sourced net new opportunities (not previously known to Keepit)
 - The seat size must be over 1,000 seats (Enterprise or Commercial customer)
 - The deal registration must be submitted and must receive final approval by the Keepit Sales Representative after qualification within the program period.
- **Award Amount:**
 - Each qualified deal will equate to a \$100 e-gift award (or local equivalent) delivered by email bi-weekly. There is a maximum of \$800 in awards, per partner seller, for the program period.

- **Verification:**

All claims will be verified by Keepit to ensure compliance with program guidelines before awards are issued.

5. Important Considerations:

- **Fraudulent Activity:**

Any attempt to manipulate deals or engage in fraudulent activity to qualify for an award will result in immediate disqualification of this, and any future Keepit programs.

- **Changes to Program:**

Keepit reserves the right to modify or terminate the Keepit Partner Power Play program at any time without prior notice.
